1. EDUCATIONAL QUALIFICATION:

Pursuing Graduate / Post Graduate in Engineering / Science, full time course in the respective discipline from a recognized Indian University / Institute (**final year students only**).

2. DURATION OF INTERNSHIP:

The duration of internship/project training work will be for a period of 06 months. Completion Certificate will be issued to students after completion of 06 months internship from date of joining.

3. SELECTION PROCEDURE:

- The student should have good academic track record with 75% & above marks or ≥ 7.5 CGPA on a scale of 10 (copy to be enclosed) from AICTE/UGC approved College/Universities.

- b. Principal/Director of institution should provide the request / referral letter to highly deserving meritorious students.
- c. Age Limit: - Below 28 Years.
- d. Shortlisted students will only be notified about the joining procedures and regarding indemnity bond.

4. APPLICATION PROCESS & INSTRUCTION :

- a. Candidates shall apply for internship in the **prescribed format** only. Application can be downloaded from www.drdo.gov.in/drdo/careers.
 - b. List of enclosures to be submitted as per application format.
 - c. Duly filled in application along with the enclosures may be scanned and forwarded to this laboratory through mail to hrd.chess@gov.in.
5. Stipend of total Rs. 30,000/- in two installments (Rs.15,000 after completion of 3 months and Rs. 15000 after completion of 6 months) subject to attendance of minimum 15 days in a month.
6. The paid internship shall be applicable in case of 6 month duration only. Students who do not complete the 6 months internship are not eligible for the stipend.
7. Other expenditure such as lodging, boarding, transport & medical etc if any, will be borne by the individual student during the course of internship.

8. Important Dates:

- i. Last Date for receipt of application i.e. **15th July, 2025.**
 - ii. Intimation to selected Students i.e. **22nd July, 2025.**
 - iii. Date of Start for Internship Training i.e. **01st Aug, 2025.**

12. Selected students will have to submit the following documents (in original) at the time of joining:

- (a) No Objection Certificate (NOC) from college authorities on college letterhead mentioning that the student will be relieved for internship training at CHESS and that the student will be present for a minimum 15 working days in a month for training.
- (b) Police verification from local police station. Acknowledgement received from Police station to be submitted at the time of joining.
- (c) Undertaking for adherence to Indian official secrets Act, 1923.
- (d) Undertaking that interns will follow IT rules and regulations applicable for Ministry of Defence and its amendments thereof.
- (e) Selected students need to provide the bank details for transfer of internship amount.
- (f) At the time of joining, student is required to bring the Aadhar card along with college ID card for verification. They should also submit 03 nos. passport size photographs at the time of joining.
- (g) All previous semesters marks sheet in original for verification should be brought and original documents will be returned immediately after verification.
