- Registration of *BE / B.Tech. / Diploma (Engineering) & B.Com. / B.Sc. / B.A / BCA / BBA (Non Engineering)* candidates on (<u>https://nats.education.gov.in</u>) and *ITI candidates* on Apprenticeship portal (www.apprenticeshipindia.org) is mandatory. - 4. The above registration no. is liable to be verified at the time of selection / Document verification.
- 5.
