ADVANCED RIOT PROTECTION SUIT

Recent incidences of extensive use of small arms in mob situations motivated us to develop a cost effect body protection gear. The developed 'Advanced Riot Protection Suit (Level-IIIA protection)" is capable to provide additional protection against soft ballistic for

handling any type of riot situation without losing life of security personnel.

It is a modular and formidable impact resistant full body suit providing complete safety to the police and paramilitary forces during riots, civil unrest and mob situations in low intensity conflicts. It helps to absorb the impact/shock load from stone or any other hard object like baton etc. in riot condition. This is used to protect chest, shoulder, back, thigh, groin and pelvis. Additionally, it also safe guards the vital organs of security personal against 9 x 19 mm ammunitions.





It is composed of 2 set of layers system: outer soft armour panels, both at the front and back, plus shock-absorbing layer. The outer most set of layer of front, back and groin parts are made of soft ballistic layers providing extensive protection and resistance to the to the 9x19 mm ammunition. These parts are snug fit to the body and provide maximum protection to torso of body. The inner most set of layer of front and back panels are made of shock absorbing materials. The outermost of both front and back panels are supported by hard engineering plastic materials. Other part of the protection suit is made of sandwich structure of engineering plastic materials and shock absorbing materials. The inner material is soft to resist injury and minimize blunt trauma. Besides ballistic protectors are composed of hard shell with adjusted inner pad, which is covered with lining and provides protection from stone, and batons etc. Additionally, different parts of body protector are attached with velcro to provide firm griping. The entire suit is designed ergonomically which provides ease of movement to the body's joint.
