S.R.O. 13E. In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Defence Research and Development Organisation, Data Entry Operator (Group 'C' posts) Recruitment Rules, 1991, except as respects things done or omitted be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the Group 'C' Data Entry) posts in the Defence Research and Development Organisation, Ministry of Defence, namely:—

- 1. Short title and commencement.
 - (i) These rules may be called the Defence Research and Development Organisation, Ministry of Defence, Group 'C' (Data Entry) posts Recruitment Rules, 1998.
 - (ii) They shall come into force on the date of their publication in the Official Gazette.
- 2. Initial Constitution: The incumbents of the following posts in the Defence Research and Development Organisation at the commencement of these rules shall be re-designated as indicated below:—
 - (i) Data Entry Operator Grade 'A'-Data Entry Operator 'A'
 - (ii) Data Entry Operator Grade 'B'-Data Entry Operator 'B'
 - (iii) Data Entry Operator Grade 'C'-Data Entry Operator 'C'
 - (iv) Data Entry Operator Grade 'D'-Data Entry Operator 'D'
- 3. Number of posts, classification and scale of pay.— The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in Columns 3 to 5 of the said Schedule.

- 4. Method of recruitment, age limit and qualifications,—
 - (i) The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in columns 6 to 15 of the Schedule aforesaid.
 - (ii) Composition of Departmental Promotion Committee III for confirmation/promotion (Col 14 of Schedule aforesaid)
 - 1. Head of the Concerned Establishment or Laboratory.
 - Chairman
 - 2. Two senior officers of the Concerned Establishment or Laboratory.
 - Members
 - 3. An officer from another Laboratory/Establishment or HQrs equivalent to or above the rank of the members of the concerned Laboratory/Establishment.
 - Member
- 5. Disqualifications. -No person,-
 - (a) Who has entered into or contracted a marriage with a person having a spouse living, or
 - (b) Who, having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to any of the said posts:

Provided that the Central Government may. If satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to Relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons or posts.
