Notification

S.R.O. 167 In exercise of the powers conferred by clause (g) to article 309 of the Constitution, the President hereby makes following rules regulating the method of recruitment to Group posts in the Constitution Establishment and Estate Management Organisation in Defence Research and Development Organisation in the Ministry of Defence, namely :-

1. Short-title and commencement - (1) These rules may be called Defence Research and Development Organisation, Ministry of Defence, Group 'C' posts of Civil Works Cadre Recruitment Rules, 1996.

(2) They shall come into force on the date of their publication in the Official Gazette.
2. Number of posts, classification and scale of pay - The number of the said posts, their classification and the scale of pay thereunto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
3. Method of recruitment, age-limit and other qualifications - method of recruitment to the said posts, age-limit, qualifications and other matters relating thereto shall be as specified in paragraph 14 of the said Schedule.

Disqualification - No person

who has entered into or contracted a marriage with a person having a spouse living, or

(b) who having a spouse, living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts :

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing exempt any person from the operation of this rule.

5. Power to relax - Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving - Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
