NOTIFICATION

SRO 190. In exercise of the powers conferred by the proviso to Article 309 of the Constitution, the President hereby makes the following rules further to amend the Defence Research and Development Organisation Technical Cadre Recruitment Rules, 1995, namely:-

1. (1) These rules may be called the Defence Research and Development Organisation Technical Cadre Recruitment (amendment) Rules, 1999.
- (2) They shall be deemed to have come into force from 26 August 1995.

2. In the Defence Research and Development Organisation Technical Cadre Recruitment Rules, 1995, in rule 6, for sub-rule (3)(b) and (3)(c), the following sub-rules shall be substituted, namely:-

"(3)(b) The interse seniority of the incumbents of the posts of Chief Draughtsman, in the pay scale of Rs 2000-3200(pre-revised), Assistant Foreman in the pay scale of Rs 2000-3200(pre-revised) and Senior Scientific Assistant in the pay scale of Rs 1640-2900(pre-revised) shall be drawn on the basis of length of their regular service in their respective grades subject to maintenance of their original relative seniority in such grades and they shall rank enbloc senior to the incumbents of the posts of Draughtsman Grade I and Chargeman Grade I;

(3)(c) The interse seniority of the incumbents of the posts of Draughtsman Grade I and Chargeman Grade I shall be fixed on the basis of length of their regular service in their respective grades subject to maintenance of their original relative seniority in such grades and they shall be placed en bloc junior to all incumbents of the posts of Chief Draughtsman in the pay scale of Rs 2000-3200(pre-revised) Assistant Foreman in the pay scale of Rs 2000-3200(pre-revised) and Senior Scientific Assistant in the pay scale of Rs 1640-2900(pre-revised)".



EXPLANATORY MEMORANDUM

This amendment is consequential to the judgement delivered by the Central Administrative Tribunal, Bangalore on 21st August, 1996 in OA No.2311 of 1995 and that dated 13 Jul 99 of the Supreme Court of India in Civil Appeal No.7314/97. This is issued to incorporate in the rules the principles laid down in judgements ibid regarding the relative seniority of all persons holding the post of Assistant Foreman vis-a-vis holders of other posts on 26-08-95 and placed in grade I of category III.

Foot Note: The Principal rules were published on 26 August 95 in the Government of India Gazette vide SRO No.177 and subsequently amended on 20th September 97 and 01 August 98 vide SRO 141 and 99 respectively.
