1. **Upper Age Limit:** 28 years as on the date of walk-in-interview. The upper age limit shall be relaxable for candidates belonging to SC, ST and OBC as per Govt. of India guidelines.
2. Only the Candidates possessing the prescribed qualification acquired from recognized University/ Institutions as on the closing date of application should attend the Walk-in-interview. NSTL reserves the final right to select or reject any candidate.
3. Candidates working in the Public Sector undertakings/Autonomous Bodies should bring '**No Objection certificate**' from the concerned authorities at the time of Interview.
4. No TA / DA will be paid for attending the Walk-in-interview.
