#### (b) Experience:

- (i) Officers / Officials who have retired from Central / State Govts. PSUs. Autonomous Bodies, Universities, Govt. R&D Organizations and possessing practical knowledge and experience in the field for which he / she is applying (as per TOR).
- (ii) Persons possessing experience of having worked with DRDO would be accorded preference during selection / appointment.
- (iii) He / She should have effective communication (both oral and written) and interpersonal skills with a strong flair for in-depth examination of his / her areas of work.
- (c) Age-Limit: The maximum age limit for all categories of retired Govt. employees for applying will be 63 years as on closing date of application.

#### (d) Remuneration & Allowances:

(i) Remuneration and conveyance allowance for Pensioners: A fixed monthly amount shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount so fixed shall remain unchanged for the term of contract. There will be no annual increment / percentage increase during the contract period. A fixed monthly amount as conveyance allowance for the purpose of commuting between the residence and the place of work shall also be allowed as mentioned below:

Rs. 5,000/- for Pay Level from Level - 12 to 14 and above.

(i)	Whether the proposed engagement is against vacant post or for specific work or project
	Specific work
(ii)	Precise statement of objectives for appointment of Consultant
	CEMILAC is presently entrusted with the responsibility of providing certification coverage for the <b>Remotely Piloted Strike Aircrafts</b> , <b>Advanced Medium Combat Aircraft (AMCA)</b> , LCA AF Mk-2 and Integration of various Missile / bombs on fighter aircraft. These projects involve certification of advanced technologies like Stealth structures / Airframe (statics & dynamics), internal weapon bay, landing gear and integration of power plant etc. Various DRDO laboratories, Public sector units, other government organizations and academic institutions are developing various equipment / sub-systems / systems for the above-mentioned platforms. Indigenization of critical technologies like ejection seat, launchers for airborne stores, landing gears, flight control actuators, control stick, radome, stealth materials are being taken up by various DRDO laboratories. CEMILAC provides concurrent certification for all these design and development activities. In the recent past, CEMILAC has observed increased retirements of Senior Officer / Designer / Certification personnel in the Aeronautical discipline and was also unable to realize the Consultant through recruitment at Junior Level for smooth transition of expertise. This has resulted in exodus of knowledgeable manpower for certification of critical systems. The above projected activities necessitate the requirement of dedicated and experienced manpower to provide timely certification coverage to the D&D activities. Since the existing manpower is very meagre to handle these projects, it is proposed to utilize expertise of experienced personnel in the field of design, development and testing of airborne systems / equipment by engaging them as consultants to support the airworthiness certification activities.

	CEMILAC is vested with the responsibility of providing airworthiness certification to Military Airborne subsystems. This involves safety of flight and prevention of collateral damage during flight testing, design and development phase. There is also requirement to collate all Defect Investigation and Court of Inquiry to derive important lessons for prevention of such occurrence in future. As CEMILAC deals with Military Aviation requirement especially helicopters, it would be prudent to hire an Ex-military helicopter pilot who has good knowledge and experience in flight safety. Towards this there is a requirement of an experienced military aviator with the background of Flight Safety & Airworthiness along with experience of dealing with production agencies.

#### Terms of Reference (TOR) for Engagement of Consultants

(i) Whether the proposed engagement is against vacant post or for specific work or project:-

The proposed engagement of Admin Consultant is not against vacant post but for the specific work.

(ii) Precise statement of Objectives for appointment of Consultant:-

CEMILAC, Bangalore is controlling body for 14 RCMAs which are situated across the country. The Outstation RCMAs are self-accounting establishments and CEMILAC is exercising the supervisory control over these RCMAs. All administrative and budgetary related activities for outstation RCMAs are monitored / supported independently by Regional Directors of RCMA.

In the recent past, RCMA(Nasik) has lost only One Admin Assistant who has been promoted to STA 'B' through LDCE and also has observed increased retirements of Senior Officers in the Administrative and allied discipline and was also unable to realize the Officers through recruitment at Junior Level for smooth transition of expertise. This has resulted in exodus of knowledgeable manpower for dealing with various administrative, budgetary and purchase management activities.

For carrying out tasks efficiently related to Administration and accounts as there is no manpower available in Admin Cadre of any rank to carry out the day to day work and smooth functioning of this Establishment, a retired govt. employee is urgently needed.

a) Discipline or domain, where engagement of consultant is required.

Essential Qualification : Any degree from recognized University Administrative & Establishment matters, DPC & LDCE, Pay Fixation & Pension and Court Cases related to these domains

b) The expertise/skills/knowledge required for engagement as consultant.

The consultant should have thorough knowledge and expertise in handling administration and accounts with an experience of about 20 years. In addition to this, he should also have knowledge about conduct of DPC and LDCE, maintaining reservation rosters in Govt. promotion schemes (DPC & LDCE based FCS) and related legal matters. The consultant should have experience of independently dealing with subject matter as a Head of the Group / Division in the Department.

#### FOR ENGAGEMENT AS CONSULTANT IN THE LABS / ESTTS / UNITS OF DRDO

- 1. The consultant shall perform the services as per Terms of Reference (TOR) and the task / jobs assigned to him / her by the Director of the concerned Lab / Estts / Unit, where he is engaged.
- 2. The working hours would be that of the working hours or the Lab / Estts / Unit where he is engaged.
- 3. Under special circumstances, the Consultant could be called for services on holidays or beyond normal working hours for which no other benefits / leave will be granted.
- 4. The consultancy will start for a period of one year from the date he / she enters into the contract agreement with DRDO.
