2. General Terms & Conditions:

2.1 Experience:

(a) Officers/ Officials who have retired from Central/ State Govt., PSUs, autonomous bodies, Govt. R&D Organizations and possessing practical knowledge and experience in the field for which he/she is applying (as per TOR enclosed).

(b) Persons possessing experience of having worked with DRDO would be accorded preference during selection/appointment.

(c) He/ She should have effective communication (both oral and written) and interpersonal skills with a strong flair for in-depth examination of his/her areas of work.

2.2 Age Limit :- The maximum age limit for all categories of retired employees for applying will be 63 years as on closing date of application.

2.3 <u>Remuneration & Allowances</u>:-

The details of Remuneration and Conveyance Allowance are as follows :

- (a) <u>For Pensioners</u>: A fixed monthly amount shall be admissible arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount so fixed shall remain unchanged for the term of the contract. There will be no annual increment/percentage increase during the contract period. A fixed monthly amount as conveyance allowance for the purpose of commuting between the residence and the place of work shall also be allowed as mentioned below.

(d) **Drawal of Pension.** : A retired Govt official appointed as a Consultant shall continue to draw pension and the dearness relief on pension during the period of his engagement as a Consultant, if eligible. His/her engagement as consultant shall not be constructed as a case of re-employment

(i) Whether the proposed engagement is against vacant post or for specific work of project:-

The proposed engagement is for the RCI Project MRSAM for production and delivery of missiles to both the users (IAF & IA).

- (ii) Precise statement of Objective for appointment of Consultant:-
 - Medium Range Surface to Air Missile (MRSAM) is a joint development programme of DRDO with Israel Aerospace Industry (IAI) for Indian Air Force (IAF) and Indian Army (IA).
 - The MRSAM weapon system have been designed, developed and tested. The user trials including missile firing also have been completed and the weapon system is under induction.
 - The objective of appointment of Consultant with an experience in integration, production and testing is to meet stringent time schedule and to expedite the production of missile at M/s.BDL, Hyderabad.
 - The role of Consultant will be coordination for production, integration and testing activities of missiles in a time bound manner.
