Three years experience of teaching in Hindi and English or research in Hind or English under Central or State or Governments or Autonomous Body or Statutory Organisations or Public Sector Undertakings or Universities or recognized research or educational institutions.

Desirable:

Studied one of the languages other than Hindi included in the 8th Schedule to the Constitution at 10th Standard from a recognized board.

Note 1: The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation including period of deputation in another ex-cadre post held immediately preceding, this appointment in the same or some other Organisation or Department of the Central Government shall ordinarily not exceed three years. The maximum age-limit for appointment on deputation shall not exceed fifty six years as on the closing date of receipt of applications.
